Our 121RN Bylaws state that the "Executive Board shall be composed of Local Union officers, all Chapter Presidents, or permanent designee, plus one elected Representative for every 400 members, or portion thereof..." Elected Representatives are paid a stipend for their service and may also be Chapter Officers.

#### **Eligibility Requirements**

- Must be a member in continuous good standing for the past two years (defined as continuously current on all member dues since December 1, 2019). For new units that have been chartered less than two years, nominees must have been member in continuous good standing since charter.
- No person who has been convicted of a felony within the last 13 years as defined in Section 504 of the Landrum-Griffin Act shall in accordance with the provisions of applicable law be eligible for nomination.

#### **Chapter Vice President**

- Takes on roles and responsibilities of Chapter President in his/her absence.
- May also be a member of our Executive Board.

#### **All Executive Board Representatives**

- Support and carry out the decisions of the Executive Board.
- Are familiar with and support our Union contract.
- Participate in Union meetings and activities; encourage co-worker participation.
- May participate in Labor-Management and other committees to improve workplace conditions.
